Honorable Mayor and City Councilor Members:

I am pleased to submit the 2024 International Falls Police Department Annual Report to you and the residents of International Falls. This report contains a summary of the events and operations the Police Department undertook in 2024.

2024 saw the International falls Police Department evolve and change in many aspects. Faced with the need to replace and hire nearly one third of our workforce, the first quarter of 2024 comprised of testing, interviews, and training new employees. The professionalism of our senior staff members cannot be understated during this time of transition.

After the initial training and orientation, we saw the new officers quickly adapt to the community, attending and coaching school functions and participating in charity events. It is also worth noting that activity levels for 2024 were the highest since tracking began in 2018.

Administration worked to train new Investigators and Sergeants. We created the International Falls Police Department's first Drug Task Force, which held monthly informational sessions with U.S Customs and Border Protection. We also implemented the Emergency Response Team (ERT). This team was created to respond to critical incidents in which a typical police response is insufficient. The ERT held monthly trainings at various locations to practice movement drills and defensive tactics.

The IFPD made the necessary steps to implement portable recording devices, which will take place in Spring of 2025. This involved a public input period of thirty days, a public input period during a council meeting, and drafting policies to govern the devices and their use.

As you can see, the IFPD continues to bring first-rate public safety services to the community we serve. This is done through community policing, innovation, proactivity, and dedication to citizens.

I would invite any who would like a more in-depth view of the police department to speak with me.

#### **Mission Statement**



# **Staffing**

The International Falls Police Department is staffed by fourteen full-time licensed police officers and one part-time administrative assistant. Our street level operations are staffed at all times with a Sergeant and up to two Patrol Officers. Further, we have an investigator on duty seven days a week. In addition to their standard duties, IFPD Officers fulfill other roles to achieve our mission and goals. For your reference I have given an abbreviated listing of additional duties outlined below. A key goal of this administration is the creation of lines of succession. You will note duties mirrored at various command levels. It is important that all levels of this department contribute to the mission and goals and provide insight to upper staff members.

#### 2024 Statistics

We responded to 6,239 Calls for Service (CFS), 1,183 of which required reports. Officers made 1.405 traffic stops and issued 490 citations. A comprehensive graphing of the statistical data is available in the appendix at the end of this report. Officers were involved in zero traffic pursuits. The police department received one citizen-initiated complaint against officers.


It is worth noting that calls for service in 2024 were the highest on record at 6,239. This is number is significantly higher than the typical call for service volume in many jurisdictions, which generally sees a call for service number at par with the population amount (International Falls recent census data placed the population at 5,802). This could be due to a variety of factors such as:

- · Increased proactivity. The increase in officer proactivity through active patrol measures has increased calls for service.
- · An "invisible populace" number. This population does not participate in the census count and is typically most at need of police services.
- · County at large boost. The surrounding county residents are a frequent presence in our community.
- Fort Frances boost. Our sister city of Fort Frances has a population of 7,466 and is present in our community.
- · Tourist boost. The recorded bridge traffic in 2024 was nearly 500,000 crossings, many of which are tourists.













# **Department Highlights**

In 2024, Officers participated in numerous events throughout the year that stood apart from the record-setting calls for service






# Investigations

We began 2024 with the promotion of Sergeant Dane Olson and Sergeant Scott Wherley to Investigators. This has allowed our department to offer an on-duty investigator seven days a week. The primary role of the Investigations Unit is to focus on criminal activity that requires a more in-depth approach than traditional street operations. This has allowed for a higher crime clearance rate within the City of International Falls and the surrounding areas. The IFPD has also worked closely with the Minnesota Bureau of Criminal Apprehension, interstate jurisdictional entities in Texas and Illinois, and local partners to reach goals. The following is a brief statistical analysis of the Investigation Units work in 2024 and solely done by Investigators' Olson and Wherley:

· Primary reports: 197

· Arrests as primary officer: 30

· Criminal Sexual Conduct: 12

# **Drug Task Force**

The IFPD Drug Task Force is the primary drug investigation unit in our jurisdiction. The team is run by Investigator Scott Wherley, who selected the task force members through a series of interviews.

The following data is derived from incidents involving the arrest of an individual by the IFPD Drug Task Force. A more comprehensive list of all drug enforcement data is available in the Calls For Service (CFS) Appendix.

The total street value of the controlled substances seized was over \$60,000. In addition, the Drug Task Force seized two vehicles and over \$2,000 in cash.



### **Emergency Response Team**

The Emergency Response Team was created in early 2024 in response to an incident that occurred within the city in which Beltrami SWAT was needed. The decision was made to implement a team that would train regularly and respond to critical incident calls.

The team is supervised by Investigator Dane Olson, who maintains training records and coordinates trainings. Sergeant Logan Hulst and Sergeant Joshua Ballejo are the Team Commanders and were selected through a voting process by the team itself.

Sergeant Hulst received instructor training certifications in the use of less lethal projectiles such as Electronic Control Weapons (TASER), Kinetic Emergency Projectiles (less-lethal shotguns), and Gas Dispersal Devices. Sergeant Joshua Ballejo received instructor training certifications in Firearms and Defensive Tactics. This has allowed for advanced training tactics for our team to prepare for critical incidents.

Trainings for the team have included advanced building clearing techniques, defensive training tactics, and weapons detailing.





# **Department Advancements**

- -The IFPD gained approval for portable recording devices, which will be implemented in Spring 2025
- -The IFPD applied for and received grants in various amounts which was utilized to offset budgetary costs, such as:
- · \$20,228.00 for operational overtime
- · \$3,390.00 for fringe benefits
- · \$10,500.00 for equipment (vehicle laptops)
- · \$5,860.00 for mileage reimbursement
- · \$14,000.00 in training reimbursement
- \$150,290.96 in Minnesota Police Aid (an increase from \$128,858.17 in 2023)
